#### OVERVIEW

The Kalamazoo County's Treasurer's Office has commissioned the development of an application to help automate the reporting and payment of the monthly accommodation taxes. This document will help you use and understand that system.

- 2. Create a transparent environment for you to see how your taxes are computed and how much you're paying over a given period.

#### SIGNING UP FOR A SYSTEM ACCOUNT

#### THE LOGIN PAGE

You must have an email address for your business to use for system access. This email will be used to login to the system and to reset your password. To request an account, either contact the Treasurer's Office or press the Request Account link on the Login Page.

1. On the Log in page, press on the "here" link. This will take you to the 'Request Account' page.

#### **REQUESTING YOUR ACCOUNT**

	Once your account has been created, you will recieve an email directing you to the login page where you will need to reset your password. Please allow 1-2 business days for processing once you have submitted your request.

- 1. Enter your business information, including the email you would like to use for system access. The Login Email can be different than the email you use for general system correspondence.
- 2. Press the Request Account button to send an email requesting an account be generated for your business. You will receive a message on the page validating that your request has been sent.

Please allow 1-2 business days for your account request to be processed by the Treasurer's office. You will receive email confirmation once it has been processed.

#### **EMAIL CONFIRMATION**

Once your request has been processed by the Treasurer's Office, you will receive an email you will receive an email similar to the one displayed below:

To complete your registration, please click on the **Create Password** link below. You will be taken to a web page that will ask you to enter a new password for your account. Once you set your password, you will be able to login to your new account using this email address and your newly created password.



1. Click on the "Create Password" link to take the final steps in creating your account.

#### Note for those registered with multiple accounts:

You will receive an email showing you the accounts you are registered for with each new account you register. You must create the password as described above to finalize the registration for all subsequent accounts. You only need to go through the Create Password process once and then you will have access to all accounts you are registered for.

Emails for account registrations after the first are informational only.

#### **CREATING YOUR PASSWORD**

Clicking on the "Create Password" link in your email will take you to the following screen:

- 1. Make sure your Email address is correct and then enter a password and confirm it. The password must have at least 6 characters, a numeric value, both a capital and lower case letter, and a special character (not a letter and not a number).
- 2. Press on the Reset button to create your password and move to the next step.

- 1. Enter the email and password that you registered your account under with the County.
- 2. Check the Remember Me check box if you want the system to remember you (you don't have to login every time). This setting is computer specific. If you login on one computer and check this box, it will not remember you on another computer.
- 3. After you have entered your login email and password, press the Log In button to enter the system.
- 4. If you forget your password at any time, you can click on this link to reset your password. This process will be very similar to the process you went through to create your password initially.
- 5. You can click on the County logo to go to the Treasurer's website.
